SPECIAL PROVISIONS:



Signing Fee

Within thirty (30) days after the Effective Date, Grantee shall pay to Owner, as a signing fee, the sum equal to the greater of (i) \$7.50 per acre of Owner's Property that is subject to this Easement Agreement or (ii) \$1,000.00.

Annual Payments for Easements and Other Agreements

For each Extended Term Year, Grantee shall pay Owner annual payments equal to \$15.00 per acre of the Owner's Property (the "Acreage Payment") and \$1,000.00 per occupied residence located on the Owner's Property (the "Occupied Residence Payment") (collectively, the "Annual Payment").
